

Declaration of Residency | Form C

Oklahoma Film Enhancement Rebate Statutes: Title 68, Chapter 1, Article 36A - Compete with Canada Film Act, Section 3623 and Section 3624

The Oklahoma Film + Music Office (OF+MO) qualifies wages paid to cast or crew members who are Oklahoma Residents or considered Oklahoma Expatriates as Oklahoma expenditures. All cast and crew the production intends to qualify as an Oklahoma Resident or Expatriate must fill out a Form C to qualify. Each Resident or Expatriate is required to register (or update his/her current listing) in the Oklahoma Production Directory at OKFilmMusic.org.
